My daughter Noa became a Bat Mitzvah during the pandemic. Instead of standing on the bimah at The Jewish Center (TJC) and reading Torah before a sanctuary full of family, friends and congregants, we marked this milestone occasion much differently. A Zoom service was created from our living room, with a homemade ark, a borrowed Torah, and a transformed child. The emotional journey to accept and embrace the changes imposed on her only reinforced Noa's commitment to her Jewish identity and to our TJC community. This served as an important reminder about the meaningful role of TJC in our lives. It's the place where we have educated our children, celebrated holidays, built friendships, volunteered our time, participated in social action and maintained a connection to community. TJC truly

represents a cornerstone of our lives, and I hope it can serve in the same way for future families.

That is why we decided to leave a LIFE & LEGACY Promise to TJC to do our part to ensuring a future for the congregation. And we left our Promise in an easy way that also engages our family in giving today. We opened a donor advised

Through a DAF, you can support any cause - Jewish or secular - at any time, and you can designate recipient organizations (just like a beneficiary of an IRA or life insurance policy) to receive the fund's assets upon your passing. Taking these steps were a win-win for our family. We get to support our favorite causes today and help support TJC tomorrow. Noa's birthday is next... and I can't wait to learn which charity she has chosen to support through the fund.
